1. **MINUTES OF PREVIOUS MEETING** were presented, agreed and signed as a true record.
2. **MATTERS ARISING FROM THE MINUTES**
 - 2.1 NY Police attendance & report. (PCSO Mainprize)
 - There has been little reported criminal activity in the parish apart from one reported theft of a Yamaha motorcycle from premises at Lealholm. This incident is still under investigation. There have been several reported thefts of bicycles in neighbouring parishes (Egton & Danby) and the police ask that people be vigilant and ensure all such property is secured when not in use. All incidents should be reported using telephone no. 0845 6060247.
 - 2.2 EVRDC – Glaisdale rail signal box – survey.
 - Members had been circulated with a draft copy of proposed survey document in advance of the meeting and comments forthcoming indicated that the document should be printed and distributed asap with the addition of a closing date for response. It was agreed that this date should be set at the end of August. Clerk to determine possibility of using the village shops at Glaisdale & Lealholm as drop off points for completed surveys in addition to the on-line and posting options. 500 survey forms to be printed.
3. **PLANNING**
 - 3.1 **Applications :**
 - 3.1.1 NYM/2010/0522/FL : Application for change of use and conversion of former chapel to holiday letting cottage at Glaisdale Methodist Church, High Street, Glaisdale.
 - Application supported in principle, members would prefer the chapel to be converted for use as permanent dwelling rather than holiday letting. This would encourage occupation by local family with consequent benefits to the community & schools etc.
