7. MATTERS OF INTEREST RAISED BY MEMBERS

7.1 NYCC Highways Issues

- **Members voiced unanimous concern for the standard of repairs carried out during the recent road resurfacing operations in Glaisdale parish. Inadequate materials and shoddy application have resulted in an appalling finish which is way below any acceptable standard. Clerk charged with ensuring that NYCC are made aware of GPC concerns and that members need to see that appropriate remedial action is undertaken without delay.**
- **Overhanging branches at the bottom of Pennocks Bank in Glaisdale is causing a hazardous lack of visibility to motorists wishing to move out onto the main C56 road. NYCC to be requested to arrange for vegetation to be cut back.**

7.2 Bridleway access – Browside to Glaisdale Rigg

- **Members requested that the clearance of vegetation promised by NYMNP A some time ago, and which is blocking the use of this bridleway, be commenced without delay. Clerk to request NYMNP A to give some priority to the original request.**
