- 4.3** Request received from Esk Moors Active Ltd for consideration of financial support for the Heather Hopper service operated locally.
- Members received this request and, after due consideration, determined to offer a small donation of £50.00 to the running costs of this charitable service. Members believe that although the Heather Hopper service does occasionally provide assistance to local parishioners, it is primarily used by neighbouring parishes from where the bulk of the looked for support should be sought. Donation proposed Cllr NH, seconded Cllr RN. All members in agreement. Cheque 100086 issued in payment.

- Members advised of only quotation received for this work was from CE Featherstone and that quotation also included an extra item for the repair of the seat at Shaw End crossroads which is detailed on the schedules as due for replacement.
 - Members discussed the merits of repair over replacement and agreed that on this occasion the seat should be repaired and the extra detail on the quotation be allowed and included.
 - Proposal to offer work to CE Featherstone made by Cllr CH, seconded Cllr NH. All members in agreement. Clerk to offer work accordingly.
