3. PLANNING
 - 3.1 Applications :
 - 3.1.1 NYM/2019/0659/FL - Application for use of land for storage of builders materials together with laying of road planings and use of Common Land for farm storage purposes (retrospective) at Hall Garth Farm, Glaisdale.
 - Members were concerned at the detail presented with this application which suggests that permission for such use of Common Land was approved by Danby Court Leet (DCL) almost 2yrs prior to this application and that the wording of the planning application does not include this limitation on any use of the land, also DCL permission did not include the storage of farm machinery etc. on anything other than an 'occasional' basis.
 - Members are aware that the existing use being made of this land does not comply with either the described intention as noted in the NYMNPA application, nor does it comply with the DCL permissions given. Items stored on this land currently have been there for some time and cannot be considered as 'occasional' use.
 - Members are also concerned that this area of land, as designated Common Land, is now effectively no longer available to those with rights of Common in this area and is a derogation of their rights. Members are also concerned that the area described on the
