- 3.1 Applications:
- 3.1.1 NYM/2018/0347/FL Amended application (retrospective) for construction of replacement balcony to rear at 8 Park View, Glaisdale.
 - No Objections raised. It was noted that this application was heard at the Planning Committee meeting held earlier today and that approval was given for the work already done on condition that screening work was also incorporated to mitigate the privacy issues raised by neighbours. The attached conditions to apply in perpetuity.

4. FINANCE

- **4.1**** Receipt of invoice from JJ Harrison Ltd for grass-cutting services throughout the parish during June and July. For approval and payment.
 - Invoice ref 6026 received from JJ Harrison Ltd for grass-cutting work completed during June and July. Invoice approved for payment - proposed CIIr RN, seconded CIIr CH. All members in agreement. Chg 100088 issued in payment.
- 4.2** Authorisation required to pay Information Commissioner for Data Management fee due as required under the GDPR regulations 2018. This is an annual fee payable to the ICO by all Data Handling organisations and authorities in the UK. This will be GPC's first payment under this legislation.
 - Members informed of legislated requirement for GPC to pay a 'Data Controllers' fee to the ICO to allow processing of data under the GDPR regulations. The fee is £40 per annum (£35pa if paid via direct debit instruction) Members agreed that payment should be made via D/Debit. Clerk to set the instruction with GPC bankers for immediate and subsequent payments.
- 4.3** Annual graveyard maintenance grants due for distribution throughout the parish. Payment authorisation required for grant payment to : Glaisdale & Lealholm PCC¹ ; Lealholm RC church² ; Glaisdale Head Methodist Chapel³.
 - Annual parish graveyard maintenance grants due for the 2018/19 financial year.
 Payment proposed by Cllr CF, seconded Cllr RN. All members in agreement.

- 4.4 Request received from Butterwick Hospice Care organisation for financial support.
 - Request from Butterwick Hospice organisation for financial support to assist their
 operations in the local areas. Members were aware that GPC has supported this
 organisation on numerous occasions in the past but also feel that the organisation
 has recently increased the frequency of such requests to an unacceptable level
 and that they do not provide any indication of how many local people they
 currently have in their care facilities in order for GPC to judge what actual benefit
 parishioners gain from any funding provided.
 Members agreed that on this occasion the request should be declined.
- 4.5** Request received for financial support from Whitby & District Community Transport organisation and for assistance in publicising the need for additional volunteer drivers for their Community Car Service.
 - This organisation does provide regular and welcome support to Glaisdale parishioners and members were agreed that they are deserving of support from GPC. Proposal to provide donation of £50 suggested CIIr RN, seconded CIIr CF. All members in agreement. Chq 100092 issued in payment. Whitby & District Community Transport organisation also requested help to publicise their urgent need for additional volunteer drivers. Members agreed to 'spread the word' and provided posters will be positioned throughout the parish to increase public awareness.

- 5.1.1 Request from Egton Parish Clerk, Lucy Fletcher, for GPC to consider participating in the shared purchase of a Vehicle Activated Roadsign (VAR) for deployment throughout all of the contributing parishes. - 7.1 Highways Issues
 - Streetlamp S24 (High Street, Glaisdale) not lit.
 - Highways excavation on Arncliffe Terrace (outside 'Wayside' cottage) has been left 'open' for some considerable time without any work ongoing. Members would like work to be completed or for the excavation to be closed until such time as resources are available to complete that work.

- Cllr CH brought to members' attention that a roadside commemorative stone near to
 Fryup End Farm has been recently re-discovered and it is not known whose responsibility
 the stone is as regards care and maintenance. Members were also not aware of the
 stones' existence as it does not figure in any council records, at least for the last thirty
 years. The stone appears to record and recognise the removal of the numerous gates
 which impeded progress along the dale-side road prior to the road being adopted by the
 highway authority of the time.
- It appears that local residents have taken action to clear vegetation around the stone to
 make it visible to passers-by and to prevent accidental damage by verge cutters etc.
 members agreed that this action appears to be the best way of caring for a piece of local
 history relevant to residents in that locality.
